Product Materials

Bacterial resistant and free of added chemicals. The unit is a 304 brushed stainless steel shroud, vacuum formed ABS changing surface with a powder coated steel frame.

Installation

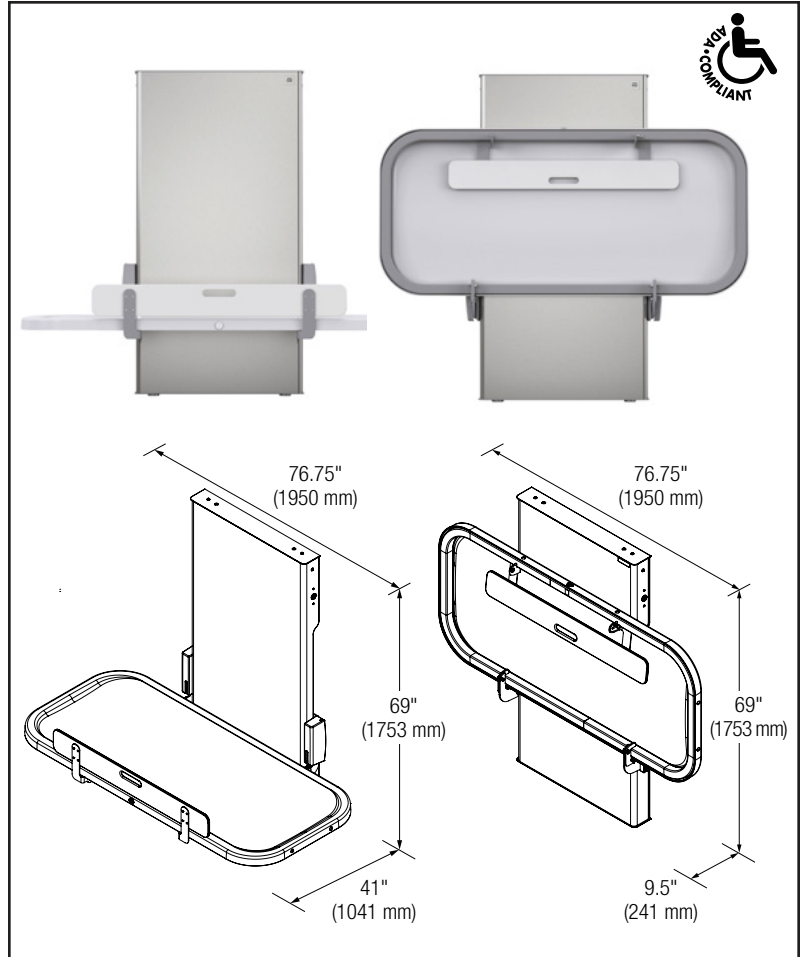
