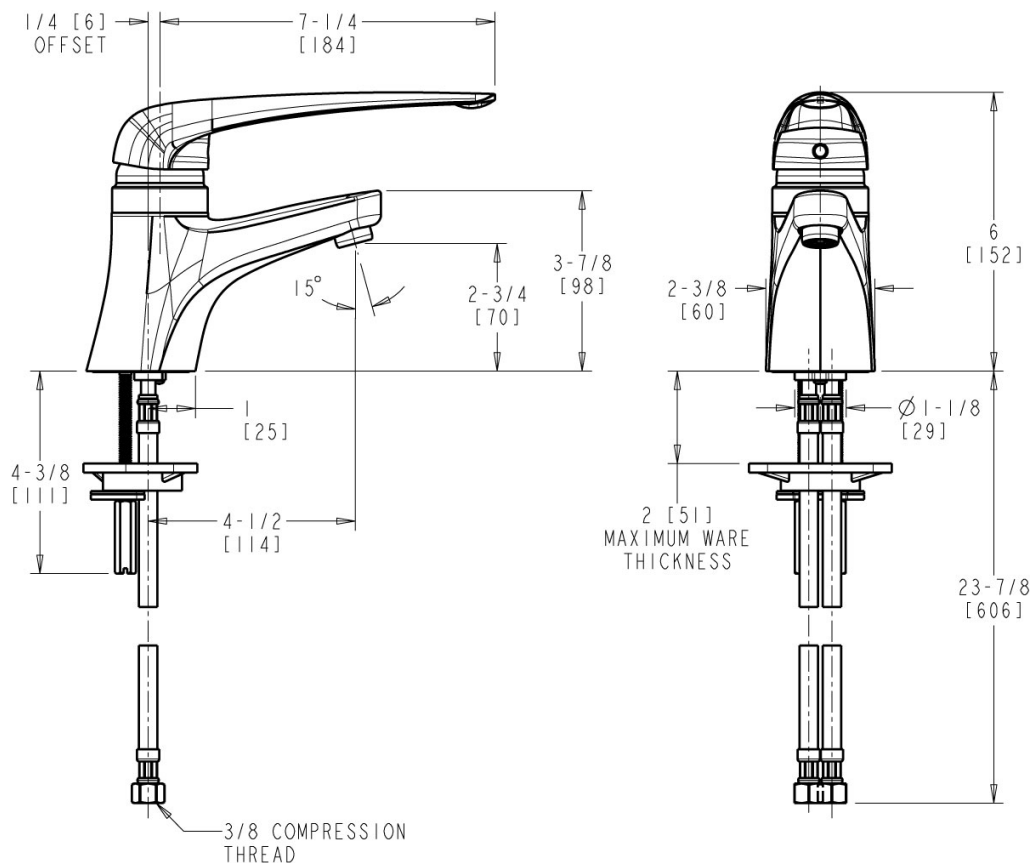

Rigid, cast brass spout, 4-1/2" center-to-center; ADA-compliant handle, 7-1/2" center-to-center. 1.5 GPM (5.7 L/min) vandal-resistant, pressure compensating, non-aerating, laminar outlet. Ceramic mixing cartridge, includes thermostatic scald protection. Cartridge includes Integral inlet check valves to protect against cross-flow. Flexible supply hoses included. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, ASSE 1070/ASME A112.1070/CSA B125.70, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.
