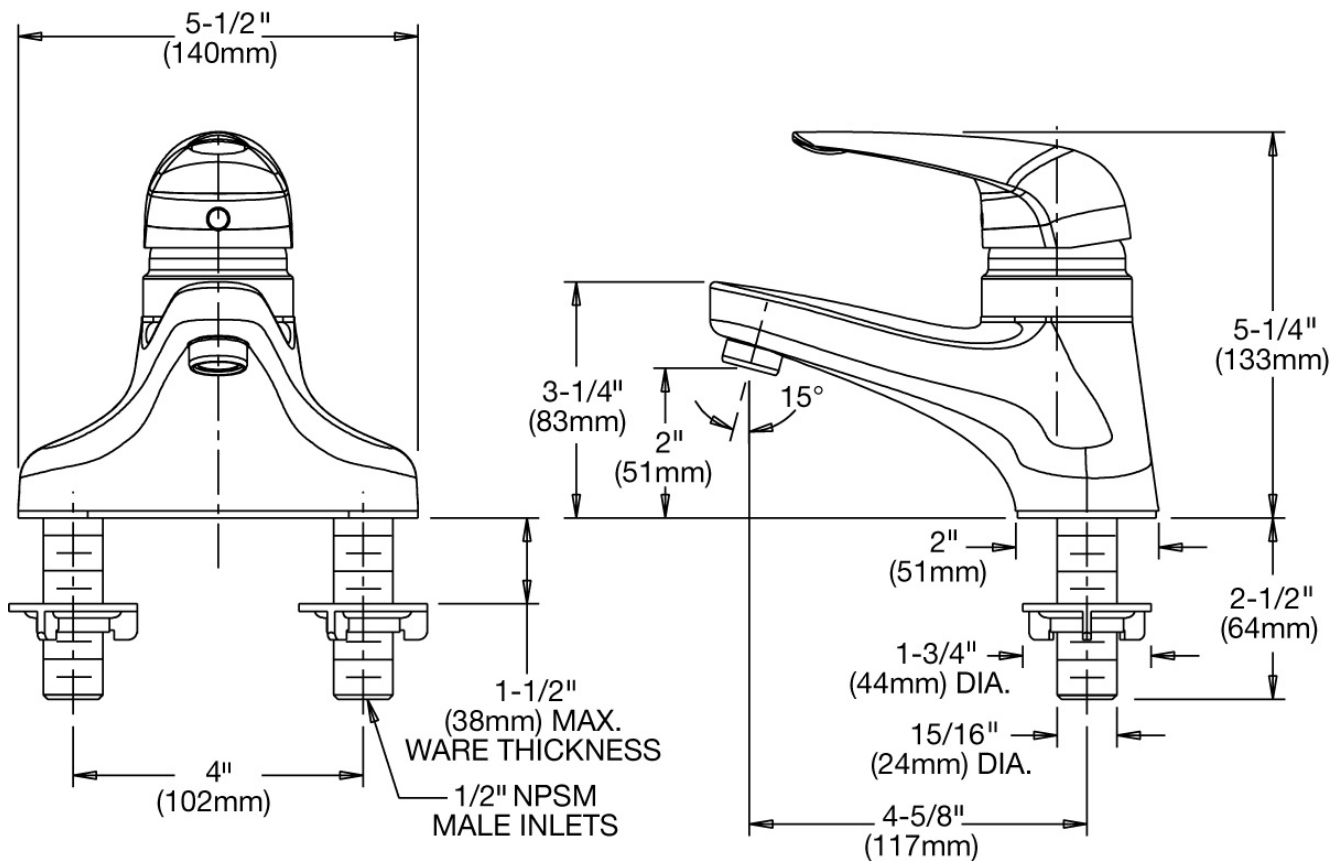

Chicago Faucets No. 420-E74ABCP, Sink Faucet for hot and cold water, single lever, deck-mounted with 4" fixed centers, chrome plated. Rigid, cast brass spout, 4-5/8" center-to-center. 1.0 GPM (3.8 L/min) pressure compensating, non-aerating, laminar outlet. 1/2" NPSM supply inlets for 3/8" or 1/2" flexible riser. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



**Operation and Maintenance**
