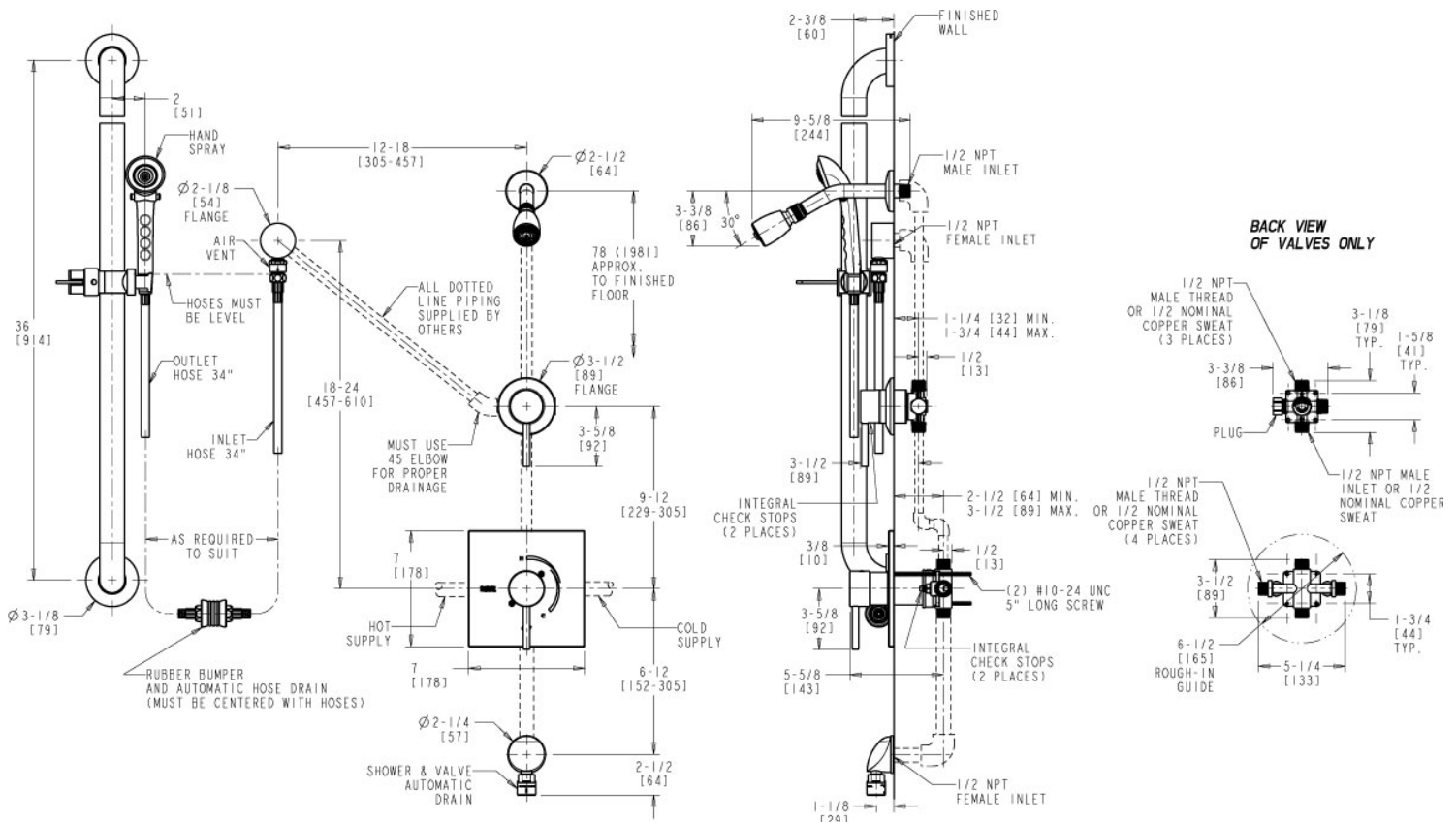

Architect/Engineer Specification

Chicago Faucets No. SH-TP6-32-034, Shower System with Auto-Drain®, thermostatic/pressure balancing valve, wall-mounted. Chrome plated. Includes shower head with ball joint, 2.5 GPM max. flow rate @ 80 PSI, thermostatic/pressure balancing cartridge; wall elbow with in-line air vent, 2.5 GPM hand spray with pause control; two 34" white vinyl hoses with automatic hose drain, 36" wall-mounted ADA grab bar with hand spray holder. Auto-Drain® diverter valve switches between shower head and hand spray. 1/2" nominal copper and 1/2" NPT hot and cold supply inlets and outlets. Shower valve cycles from cold to hot. Wall plate includes embossed and color-coded temperature index. Integral service stops with checks to prevent cross-flow. Hand spray incorporates a non-positive shut-off feature in accordance with ICC A117.1-2017, Section 607.6. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, and ASSE 1016.



Operation and Maintenance

Installation should be in accordance with local plumbing codes. Flush all pipes thoroughly before installation. After installation, remove spout outlet or flow control and flush faucet thoroughly to clear any debris. Care should be taken when cleaning the product.
